




Growth of 80 and older from 2018 to 2035 is 240%

Population 60+ Peaks in 2025



Where do seniors live?






Percent of Total Population Age 60+





57% of Fairbanks Pioneer Home residents have a diagnosis of ADRD (July 2018)



Household Income of Population 65+




Medicare in the FNSB

- July 2019, 11,535 people 65 years and older receive Medicare.
- In 2035 17,122 people 65 years and older will be eligible for Medicare.
- That is 5,587 more seniors who will be enrolled in Medicare. That is a 48% increase in 15 years.

Senior Survey - Key Findings 351 Surveys Completed Top Concerns For Seniors In FNSB

- 1. Access to health care
- 2. Maintaining physical health
- 3. Financial security
- 4. Having enough food to eat
- 5. Fuel Costs
- 6. Affordable and accessible housing

Senior Survey – Housing

- 85% plan to stay in Alaska
- 73% live in a house or condo that they or a family member owns.
- 10% of respondents live with their adult children
- 77% say their homes need some form of modification
- 76% expect to be living in the same home five years from now
- 9% would like to live in a smaller space in 5 years

Senior Survey – Help with Activities of Daily Living

- Top ADL/IADLs Needs
 - Preparing meals (40% find this difficult, or cannot do this themselves)
 - General home maintenance (35% difficult/cannot)
 - Shopping (20% difficult/cannot)
 - Household chores (19% difficult/cannot)
- 23% say they can get help only some of the time or never (6%)
- Top ways of obtaining help
 - Family, friends/neighbors, and agency assistance

Senior Survey – Elder Abuse and Exploitation

- 23% said they or someone they knew experienced elder abuse or exploitation
 - Financial exploitation (86%)
 - Emotional abuse (49%)
 - Neglect (31%)

50% reported the abuse 43% of received help





- •General relief waitlist of 200+ statewide to get access to this funding source while people are waiting for Medicaid waiver assessment
- •Lack of care coordinators to get Medicaid waiver assessment
- •Shortage of dementia care for people with behavioral challenges, even hard to serve in Denali Center

Care Coordination

- •People must have a care coordinator to get access to Medicaid waiver services
- •10 providers; all are full
- •ADRC has seen 200 people since opening in October 2018 who needed PCI prescreen (person-centered intake) for Medicaid waiver, 10 have got a care coordinator

Barriers

- Must be certified by State of Alaska
- Required to have three months operating reserves
- Must be "conflict-free"
- 1-year training program

Key Findings

- FNSB has the entire continuum of care, but within the borough there are gaps
- Greatest needs:
 - Quality, affordable senior housing Long waitlists for subsidized, income-restricted senior housing ~149 units by 2025
 - Coordinated transportation plan for seniors
 - Care coordination
 - Assisted living for people with challenging behaviors, many related to dementia
 - ~153 beds by 2025
 - Funding for in-home services to keep seniors living independently. While some services (like personal care, meal preparations, chore services and respite) are available, limited seniors have the availability to pay out of pocket.
 - Workforce development for personal care providers
 - Primary care doctors who accept Medicare
 - Home modifications
 - Legal resources + advocacy services

Fairbanks Senior Center In-House Supports



Nutrition, Transportation, and Support Services (NTS) Homemaker/Chore Services

Fairbanks Senior Center is a non-profit organization established in January 1973. Our vision is to promote the independence of Alaskan seniors while assisting them in leading productive and meaningful lives. We strive to meet the needs of 60+ older adults by providing services such as Meals-On-Wheels, nutrition, transportation, and home chore services. A congregate meal program is lunch and social activities to meet new people, one big family.

We served 5,717 transportation units, 12,574 congregate meals, and 3,232 homes with chore services. Let's talk exercise classes! The Senior Center offers 8 different exercise classes to keep seniors strong and had a grand total of 8,156 exercise units.



Meals-on-Wheels Program

Meals-On-Wheels Program offers meal services to people 60+ and older who are in need or facing the threat of hunger. Our community-based Senior Nutrition Program delivers a daily hot meal to those whose mobility is limited and are eligible to receive them. We strive to make a difference in the lives of our neighbors, our growing senior population, and our local Fairbanks and North Pole and Delta Junction communities. Last year we delivered 53,767 meals.



Senior Companion Program (SCP)

Senior Companion Program is open to volunteers age 55 and over who can serve between 5 and 40 hours a week, assisting other adults in our community with daily living tasks. Some of the services the volunteer may provide are light house chores, meal preparation, transportation to doctor appointments, shopping or running errands, respite care, and most importantly, companionship. Our volunteers receive a stipend, meal and mileage reimbursement, holiday pay and accrue paid time off, all 100% tax free income. We provide training and other start up costs, and our services are free to the clients we serve. Our goal is to assist the clients we serve so they may remain in their own homes living independently for as long as possible. Last year, SCP volunteers served a total of 15,062 hours.

Aging at Home (AAH)

Aging at Home Fairbanks (AAH Fairbanks) is a membership organization for older adults in the Fairbanks area. Members help each other remain independent and engaged as they age. For an annual membership fee, members will have one-call access to services and support to help them stay in their homes as they grow older. Most services are provided by volunteers. For services that are beyond volunteer capacity, such as major home repairs and home health-care needs, members have access to a list of screened paid providers. Social opportunities, lectures, and educational workshops are added benefits!



Aging and Disability Resource Center (ADRC)

Alaska's Aging and Disability Resource Centers (ADRC) connect seniors, people living with disabilities, their families, and caregivers with long-term support services to help them live independently. The ADRC network serves Alaskans statewide, regardless of age or income level, through regional sites. Local ADRC specialists counsel individuals regarding care options and help facilitate access to community services. ADRC North is housed in the Fairbanks Senior Center, and provides services for residents of the Denali Borough, Fairbanks North Star Borough, Southeast Fairbanks Region, Yukon Koyukuk Region, and the North Slope Borough. ADRC specialists help identify long-term support needs, explore options for meeting those needs, connect individuals with resources, and follow up to ensure needs are met.

Helping Hands- Home Modifications

Helping Hands Home Modifications is a new vital community service program at the Fairbanks Senior Center. If you are a senior or someone with a disability who needs help with small, but necessary, home repairs that you cannot do yourself and cannot find anyone else to do them. We focus on small, simple projects that improve accessibility, support safety and security, and help keep your independence while living in your home. Let us set up a time, estimate cost for parts and materials, and get permission from the landlord to work on your rental apartment, if needed. To support our costs, any financial contribution, in-kind supply of tools, common home repair parts, and safety gear is truly appreciated.
